#### What is the Consent Decree?

- Investigation by DOJ
- Pattern and Practice of Unconstitutional Policing
- ♦ Reached an Agreement in Principal on July 2016
- ♦ 77 page Document

#### Consent Decree - Paragraph 197

- ♦ Every six months thereafter as long as this agreement is in effect, the City implementation unit will produce a status report that will be filed with the Court, with a copy to the Monitor and DOJ, and shall be a public record.
- ♦ This report shall delineate the steps taken by NPD during the reporting period to implement this Agreement;
- the City's assessment of the status of its progress;
- plans to correct any problems;
- and response to any concerns raised in the Monitor's previous quarterly reports



# PowerDMS

## Document Management Simplified

NPD continues to utilize the "PowerDMS" document management system to conduct various in-service trainings, issue training bulletins and make policies, procedures and memorandums available to all members at all times.

#### Civilian Complaint Review Board



NPD continues to collaborate with the Civilian Complaint Review Board ("CCRB") in areas of policy and procedure development. On March 30th, the NPD hosted a training session with CCRB members and in collaboration with the Essex County Prosecutor's Office. This training covered Attorney General Guidelines, NPD's new corresponding policy in the area of Use of Force, Vehicular Pursuits and Domestic Violence policies.

#### Community Engagement

NPD has participated in several community engagements during the reporting period. Some highlighted community events included the NPD's successful community rollout of the new Disciplinary Process & Matrix policy and two LGBTQ community meetings to discuss the NPD's new LGBTQ policy and Newark specific training. The NPD continues to prioritize collaborative community engagement and the building of public trust.

for the two remaining precincts.


#### IT Assessment and Roadmap

During the reporting period,


- Gartner Group finalized its IT plan for the NPD

- The City of Newark is currently identifying funding sources to initiate the plans and recommendations submitted by the Gartner Group.




NPD's commitment to transparency in its procedures and performance remains a priority. During the reporting period, transparency data has been posted and updated to the NPD website.



#### 2016-2019 Frisk Hit % Citywide



#### Training for Consent Decree and Planning Division

During the reporting period, members of the Consent Decree and Planning Division "CDPD", which serves, as the Consent Decree paragraph 196 required implementation unit, attended management training at Google headquarters in New York City and a Methods of Instruction, (MOI) course to better assist in administering all NPD trainings.



#### All Force Investigations Team

In compliance with Consent Decree Paragraph 78,

- NPD created an All-Force Investigation Team, ("AFIT").
- AFIT was initiated on January 1, 2019.
- AFIT is a sub-component of the Office of Professional Standards,
- AFIT is responsible for tracking, reviewing and monitoring all uses of force in the NPD.
- In addition, AFIT is responsible for investigating serious uses of force, and may supersede any low-level or intermediate level use of force investigation.
- NPD officers are now required to report any 'constructive authority' wherein police personnel un-holster and point a firearm at a person to exert verbal command and control over the person.







#### Frontline Software for IAPro

- BlueTeam is software that allows officers and supervisors to enter and manage incidents from "the field". A simple, step-by-step internet-style interface is used, minimizing training requirements.
- Incidents including use-of-force, field-level discipline, complaints, vehicle accidents and pursuits are entered and can then be routed through the chain-of-command with review and approval at each step.
- BlueTeam allows the NPD to capture and feed the Early Warning System
